
## TAKE ACTION NOW!

## **PROVE IT Act Success Story!**



### **Good work, CCL!**



CCLer's have been hard at work writing, calling, and lobbying for this bill's support since last June!

On Thursday, January 18th, the Senate Environment and Public Works Committee passed the markup of the PROVE 1T Act 15-4 with bipartisan support!

The PROVE IT Act is a bipartisan bill that would **take the first big step towards a carbon border adjustment (CBAM).** It would task the Department of Energy with calculating the amount of carbon it takes for United States industries to create products compared to foreign competitors. Once we know this, we can determine the price to charge imports from other countries. Then we can pass a bill establishing a


CBAM!

### What's a CBAM?



Because the US has more regulations, our products tend to emit less carbon in the process of making them. Unfortunately, this often adds extra costs for US companies, and the dirtier, foreign competitors are advantaged.

A CBAM levels the playing field by placing a fee on the extra carbon footprint of these imports. This encourages foreign companies to move to cleaner sources, and Americans to buy low-carbon American products.



## The US Isn't the Only Country!

Many countries including the European Union, the United Kingdom, Japan, Canada have implemented, or are in the process of considerin their own CBAM. Let's join them!


